AN EXECUTIVE ORDER PERTAINING TO LOCAL STATE OF EMERGENCY- COVID-19 DUTY CREW

WHEREAS, the Village of Bartonville, Peoria County, Illinois is a home rule unit of government and, pursuant to the provisions of said Section 6(a) of Article VII, may exercise any power and perform any function pertaining to its government and affairs, including, but not limited to, the power to tax and to incur debt; and

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/11-1-6, provides for the declaration of a state of emergency and the grant of extraordinary authority to the Village President by the corporate authorities; and

WHEREAS, the Illinois Emergency Management Agency Act, 20 ILCS 3305/11, further provides for emergency local disaster declaration by the principal executive officer or his or her interim emergency successor; and

WHEREAS, the Village of Bartonville President executed an executive order on April 16, 2020 that the Village of Bartonville shall maintain a Village of Bartonville Volunteer Fire Department "Duty Crew" aka as COVID-19 Duty Crew with articles listing number of members physically manning the assigned station, compensation, and commencement; and

WHEREAS, the Village of Bartonville passed Ordinance 1832 on March 23, 2020- An Ordinance Pertaining to Local State of Emergency and now desires to provide for the exercise of extraordinary powers by executive order during a state of emergency within the Village; and

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

ARTICLE 1

The Village of Bartonville shall maintain a Village of Bartonville Volunteer Fire Department "Duty Crew". This "Duty Crew" will consist of a daily crew of 5 Volunteer Fire Department members to physically man the Village of Bartonville Fire Chief assigned station.

ARTICLE 2

Each person that serves on the "Duty Crew" shall be retroactively compensated \$50.00 per day for days served from MAY 26, 2020.

ARTICLE 3


The use and compensation of the "Duty Crew" shall cease at such a time when the Mayor deems the Local State of Emergency a non-necessity.

ARTICLE 4

EFFECTIVE DATE. This Order shall be in full force and effect on June 8, 2020.

SEVERABILITY. If any provision of this Order or application thereof to any person or circumstances is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Order that can be given effect without the invalid application or provision; and each invalid provision or invalid application of this Order is severable.
