Fire Chief Mike Cheatham

- Department assisted with "Pool Days" and the St. Jude/Peacock's Pub Block party.
- 5 volunteer fire fighters from Bartonville went to Wisconsin to check on the new firetruck and were able to obtain more pictures. Trustee Shawn Zachman thanked Chief Cheatham, the Assistant Fire Chief and volunteers for taking their own personal time to check on the newest firetruck and all of their dedication to the community.
- June 15, 2023, marks 30 years of enhanced 911 in Peoria County and there have been over 3.1 million 911 calls for Peoria County during that time.
- 20 Fire and 65 rescue for a total of 85 calls for May. 355 calls year-to-date, 5 calls down from this time last year. Mayor Ricca thanked the volunteers for saving the Village \$48,037.50 month-to-date (2,745 man hours) and \$195,387.50 year-to-date minus their small stipends.
