**Trustee Rhea** presented a Park report and a Trustee report:

**Park Committee Report**

- Successful concert in the park – 219 people in attendance
  - Thank you to Fire Chief Cheatham and crew for loaning the large fans.
  - Thank you to the Public Works Department for moving the picnic tables.
- Lauterbach back waters are being drained to clean up the water that will lead to better fish, foul, and plants. A bobcat was spotted on the property. IDNR is interested in trapping and tagging the bobcat for further research.
- Coffee talk on July 5 at 8am with speaker from Peoria Public Library on Ancestry to begin at 8:30am. A special breakfast of biscuits and gravy will be provided by the Limestone Township.
- Community Mulch Day – Saturday July 8 at 7am in Alpha Park.
- Family Fun Night in the Park is Saturday, July 15, 2023. There will be face painting, a scavenger hunt, obstacle course, popcorn, yard games and more.

- The library is hosting an I-Spy program in Alpha Park through Tuesday.
- Boy scout building two bridges for Lauterbach Trail as Eagle Scout project.
  - Eagle Scout prospective John Meyer was present and gave a cost estimate of \$677.11.
  - Park Committee will be paying for the materials, PAMBA will be assisting with the wood cutting (cutting day is tbd).
  - July 22, 2023, is construction day and all the detailed plans will be sent to Trustee Rhea for disbursement.

## **Trustee Rhea**

**Trustee Zachman** spoke of Limestone Baseball having individual teams and 9 teams of the 13–14-year-old age group. Trustee Zachman questioned if there was any news of Police grant. It was stated we were still waiting on audit completion.

### **PUBLIC COMMENT**

Esther Perschnick, 7316 W. Smithville Road spoke of the CO2 pipeline that is being proposed. Wolf Carbon and ADM want to bring a 280-mile pipeline from Iowa, running through the south of Peoria with the purpose of capturing CO2, compressing it, and transporting it somewhere else for storage.

Mrs. Perschnick doesn't believe that the CO2 conservation measure is the most effective way to go, and the regulations are an issue in her opinion.

Mayor Ricca stated that we will keep an eye out for future information on any development.

Fred Leibach, 3923 S. Sheffield Road thanked the Park Committee for their hard work.
