 West Peoria which meet PUEZ qualifications. PUEZ A#9 will also delete parcels off W.
 Farmington Road in the City of West Peoria.
- Property that is in both the enterprise zone and a redevelopment project area may not receive
 tax abatements unless within 60 days after the adoption of the amendments to the designating
 ordinances which established the eligibility for the tax abatements. It was noted that an incentive
 change of no property tax abatement for large community solar farms was also added in this
 amendment.
- Confirmed that the name changes from the 8th amendment to the 9th amendment was a state mandated change.
- 5 additional square miles have been added to the original allocation and pooled. Appointment of the allocation to PUEZ jurisdictions will be reviewed and granted on demand.
